Consultation Agreement

I understand that the consulting done by (Lisa M. Baker) will determine whether or not my child fits the dyslexic profile, but it will **NOT** qualify my child for Special Education services or a 504 Plan in the public school system.

I know that (Lisa M. Baker) is **NOT** in the medical field. Dyslexia is **NOT** considered a medical condition. (Lisa M. Baker) does not accept medical insurance as payment for screening. Medical insurance does not cover anything having to do with dyslexia because dyslexia is not considered a medical condition.

I know that (Lisa M Baker) is **NOT** a psychologist, and that (Lisa M. Baker) will not be conducting an intelligence test or any of the normed standardized tests typically required to qualify for special education services or to receive a formal diagnosis of Reading Disorder or Learning Disability.

This process is **NOT** intended for use in determining eligibility for school-based intervention.

However, the dyslexia consultation process will determine, with a high degree of accuracy, whether or not my child fits the classic profile of dyslexia, and if so, it will reveal which type of research-based intervention (tutoring) is needed. I know it will be my responsibility (and not the school's) to provide that type of tutoring. A list of classroom accommodations will also be provided.

I know this consultant specializes solely in dyslexia. If my child has more than just dyslexia, the consultant will not be able to identify any additional conditions he/she may have.

The results **can not** be used in a court of law or to force someone else to pay for tutoring.

I will pay for the consultation personally. I want the following service (check one):
